Companies that do business in Europe will be responsible for damages caused by a data breach.



The greatest threat to your personal privacy in the 21st century is identity theft and fraud. There are over 16 million new victims of Identity Theft, every year that are reported to law enforcement. According to the Federal Trade Commission, Identity Theft is the fastest growing crime. This new regulation is an additional law to protect customers from Identity Theft and fraud.

U.S. business shouldn't have anxiety about the new GDPR. Rather, this new law is an opportunity for the business to improve their cybersecurity posture by providing better control to mitigate the damages of data breaches.

GDPR will affect how businesses navigate thru worldwide commerce. This law may seem like an intrusion on a business, however, it can be a good tool for the business to reevaluate their current security processes and procedures and to ensure their customer's trust, increase business reputation and avoid legal entanglements.
